I covenant and agree that I shall keep secret by not disclosing to others confidential information concerning the business information, trade secrets and proprietary information of Promogirl.com, and its clients.

I agree and understand that it is of utmost importance that I fulfill, in a timely and professional manner, all work assignments for which I am placed through Promogirl.com. I understand that not showing up for an assignment damages the business reputation of Promogirl.com and the relationship between Promogirl.com and its clients. Failure to appear shall be deemed a breach of contract for which I will be held liable to Promogirl.com for the amount of compensation that I would have earned for that specific job. I authorize Promogirl.com to demand, collect, receive, endorse, and deposit all payments from work performed by me in relation to the areas covered herein and that all monies earned by me will be paid directly to Promogirl.com. I agree to defend, fully indemnify, and hold harmless Promogirl.com from and against any expense, loss, damages, and any matters pertaining to potential injures, liabilities, claims and/or lawsuits incurred as a result of my negligence, errors, omissions, conduct or otherwise, arising out of any work for which I receive from the efforts of Promogirl.com.

I understand that I am not an employee of Promogirl.com, but an independent contractor. I have exclusive control over the means, method and details of fulfilling my work obligations. Promogirl.com has no obligation to provide me with any transportation, facilities, staff, or tools of trade.
